

NORTHWEST REGION SCCA  
RACE COMMITTEE MEETING  
June 25, 2007

Race Committee meeting was held at Andy's Diner, Seattle, WA. Attendees were: Tom Masterson (Asst. RE-Race), Jay Bratton (Race Treasurer), Joan Manley (Race Secretary), Mike Evans, Bob Grass, Ken Jones, Val Korry, Frank Manley, Sherri Masterson and Bob Rygg. Meeting was called to order at 6:33 p.m.

1. Minutes of May 21, 2007 were approved with corrections: para. 3 (1) spelling of Sherri Masterson and Steve Caputo, (2) change transponders to sound equipment set up on Friday, (3) Mastersons to identify someone to procure the doughnuts; para. 7 change will to may have cars. M/S Jay Bratton/Mike Evans.
2. Treasurer's report was approved as presented by Jay Bratton. Copy is attached to secretary's file. Items discussed were expenditures and entries for both the April 28-29 Double Regional races at Bremerton and the May 26-28 Double National races at Pacific Raceways. April DR event is closed with a loss. May DN event shows a profit at this point; some entry fees are still due, expenses have been paid.
3. Chiefs' reports:
  - Flagging – Ken Jones thanked Mike Evans (who in turn thanked stewards for their assistance) for his staffing of the DN event. Mike reported that he has water left for the next event at Bremerton.
  - Timing/Scoring – Sherri Masterson reported that this was not a pleasant experience. FAX line to Drivers Services was not repaired until Sunday, then worked okay through the event. We need to have Orbitz 3 (not 1) which is in an SCCA compliant format. Computer equipment needs to be upgraded. Bob Grass and Mike Evans will check Boeing surplus for equipment; Sherri will send them requirements. Sherri would like four laptops and will need two generators at Bremerton in July.
  - Registration – Sherri Masterson said drivers can give an electronic acknowledgment of "I agree" on the entry form by checking box. She had adequate help at the DN – 158 entries with 35 in Group 6.
  - Course Marshal – Eight cases of water were used. Region banner was returned; Ken Jones had it, now in Mastersons' possession.
  - Sound equipment – Ken Jones has this and will give it to Jay Bratton for calibration.
  - Drivers Services – Joan Manley thanked Race for the two popups. She also thanked her personnel – Geri Martinsen, Medy Danton and Lois Meeker - for their excellent help.
4. BMP – magazine representatives will be at Bremerton for July event.
5. Website – July event schedules and entry forms are now posted.
6. July 28-29 Double Regional:
  - Jay Bratton is coordinating details of the event with Steve & Barb Archer, members of Big Island of Hawaii Region.
  - Saturday night menu – Sherri Masterson suggested the following menu for 150 persons: Maui chips w/island salsa, coleslaw w/pineapple and raisins, sweet potato balls, hot pork, teriyaki chicken, macadamia nut cookies for dessert.
  - Registration – stickers for photo Ids will be the logo of the Big Island of Hawaii Region.
  - Publicity – Tom Masterson (elder) will feature this event in his article in Sportscar.
  - Trophies – Victory flags with both Region emblems in color were approved. Dash plaques are to be in black/white (not color) due to cost.
  - Track sweeper will cost a minimum of 3 hours plus fuel, approximately \$342.
7. CRUZ – Port Orchard Car Show on August 12. Displayed will be 2007/08 hotrods, as well as classic/restored cars. Mark McCloskey will coordinate a booth to boost SCCA.
8. Yearend Race Party – November 17, 2007, at Bison Creek in Burien.
9. Tacoma Narrows new bridge span will be open before our July event. Round trip is \$3.
