

NORTHWEST REGION SCCA  
RACE COMMITTEE MEETING  
May 21, 2007

Race Committee meeting was held at Andy's Diner, Seattle, WA. Attendees were: Tom Masterson (Asst. RE-Race), Jay Bratton (Race Treasurer), Joan Manley (Race Secretary), Bill Deoneseus, Mike Evans, Bob Grass, Ken Jones, Frank Manley, Sherri Masterson, Mark & Kelly McCloskey, Kevin Needham, and Bob Rygg. Meeting was called to order at 6:35 p.m.

1. Minutes of April 23, 2007 were approved. M/S Jay Bratton/Bob Rygg.
2. Treasurer's report was approved as presented by Jay Bratton. Copy is attached to secretary's file. Items discussed were expenditures and entries for both the April 28-29 Double Regional races at Bremerton and the May 26-28 Double National races. The Double Regional showed a net loss with two bills still outstanding. Entries were 50 with 6 refunds. To date we have 151 entries for the Double National races; GTT may have 10 entries. July upfront money from "Big Island" has been received.
3. Chiefs' reports:
  - Flagging – Mike Evans reported that he had purchased three canopies and will get one more. Staffing for the Double National will be sparse. Sherri Masterson will contact Karters for assistance. Mike will handle the coffee detail for the A.M. meetings; Tom and Sherri Masterson will identify someone to procure the doughnuts. Ken Jones will procure the bottled water for workers.
  - Emergency – Kevin Needham had the Jaws serviced for \$450; we have five tools and three power units. Previous rally weekend was good.
  - Race Chairman – Ken Jones reported that Steve Caputo (Pacific Raceways) has volunteer fire fighters; Jason Weber is not pleased with them. Mike Evans asked about after-event worker food. Ken reported that we will have hamburgers/hot dogs on Saturday with the usual stewards' steak feed on Sunday. Ken reported that he will purchase 50 lunches per day for workers.
  - Sound – Kelly McCloskey reported that she will not be at the Double National. John Forespring will handle this with Neil Swanson's assistance. Mark McCloskey will bring the equipment. Sherri Masterson reported that the sound equipment will be set up for Friday Tune&Test.
  - Registration – Sherri Masterson thanked Karen McCoy for her help at Bremerton. For the Double National, Sherri will have Lou Ann Christensen, Margie Swanson, Lois Meeker, perhaps Betty Silver in addition to herself and Joan Manley. Camera will be available for Photo Ids.
  - Licensing – Sherri Masterson reported changes – automatic upgrades by Divisional Administrators unless the Region Chief says "No".
  - Tech – Jay Bratton said we must be able to check fuel, our meter must be calibrated and will be here next month. We will have the meter from the National office. Dan Carchano has a National tech license and can check fuel. Crew needs planks for the scales.
4. April Double Regionals – Tom Masterson thanked the drivers for helping in cleanup; it was finished at least an hour early. Paint spray gun has been fixed so barrier painting will be completed in July.
5. Bremerton Motorsports Park – No report.
6. Website – No report.
7. July Double Regional: Sherri Masterson is still researching a luau dinner for Saturday evening. Jay Bratton reported that we may have cars entered by members of Big Island of Hawaii Region.
